<u>The VVDCS Statement of Faith</u> states that We believe the Bible to be the inspired Word of God, the final authority of faith and life, without error in its original writing both in doctrine and historical details, and that all true knowledge is consistent with its revelation.

VVDCS Statement of Purpose is to:

- A. Provide information and guidance to homeschooling families who believe it is our God-given right and privilege to teach our children at home. It is our intent to provide opportunities to share our problems and our successes with each other as well as activities for learning and fellowship
- B. Be a legal covering for you by filing our private school affidavit, maintaining required recordkeeping, and administrating as your school authority to any organization who may need it.
- C. Guide you with what is legally required in educating your child.
- D. Educate and encourage the parents with information, activities and support meetings.
- E. Provide curriculum counseling, transcripts and diplomas.
- F. Provide a godly environment for our children to grow healthy academic and peer relationships.

<u>VVDCS Purpose of Education</u> follows Noah Webster's 1828 definition of education: "the bringing up as of a child; instruction; formation of manners. Education comprehends all that series of instruction and discipline which is intended to enlighten the understanding, correct the temper, and form the manners and habits of youth, and fit them for usefulness in their future stations. To give children a good education in manners, art and science is important; to give them a religious education is indispensable; and as an immense responsibility rests on parent and guardians who neglect these duties."

VVDCS Purpose of Family Unity Policy is that we believe God intends for our family life to be united and that having all the children in our household working together in the same homeschooling environment is the best way to maintain unity in our goals. We feel that having our students in differing school programs, especially public school programs would be divisive and a conflict of interest. We will not enroll families who are not able to be the main educator all of the children in their household through independent private Christian homeschooling at this time.

MEMBERSHIP OPTION #1- VVDCS Private School Satellite Program (PSP):

Enrollment in the PSP would provide multiple benefits including, but not limited to the items in the Mission Statement and Statement of Purpose, including private school enrollment, record keeping and cumulative file management, field trips, meetings, activities, newsletters, curriculum counseling, diploma, transcripts, and promotion/graduation. Membership to CHEA and HSLDA is required annually in this VVDCS Level of Membership for the concurrent school year. - 1. VVDCS reserves the right to refuse enrollment for any reason.
- 2. There is no refund or transfer of any VVDCS Fees.
- 3. FOR MEMBERSHIP 1 and 2 (PSP and Support Group): A \$25 penalty fee will be charged on any and each item turned in after the scheduled deadline. Schedule items are due on the 1st of each month. Anything postmarked after the 10th will be considered late.

Health Records

Health Reports are required to be kept by all schools in California and are subject to audit by the Health Department.

Parents must submit a copy of their children's personal immunization record upon enrollment. For transferring students, a copy of the previous school's record is sufficient.

- L The immunization record must be presented upon enrollment, with no grace period if the child is entering grade 1 or grade 7. There is also no grace period for a child, of any grade, who was enrolled in a school outside the U.S.
- Lagrangian Lagrangian

Exemptions: If a parent has personal beliefs opposing immunizations, they may sign a waiver on the back of the blue "California School Immunization Record" card (PM286). The law allows (a) Parents/Guardians to elect exemptions to immunization requirements based on their personal beliefs, and (b) physicians of children to elect medical exemptions. The law does not allow parents/guardians to elect an exemption simply because of inconvenience a record lost or incomplete and it is too much trouble to go to a physician or a clinic to correct the problem. For children with medical exemptions, the physicians' written statement should accompany the signed waiver.

Only children who have met all immunization requirements or those who have signed a waiver will be enrolled in VVDCS.

If the child is entering kindergarten or the first grade if they skipped kindergarten, they are required to have a physical exam and to submit a "Report of Health Examination for School Entry" (PM171A) or a "Waiver of Health Check-up for School Entry" (PM171B).

**2016 Immunization Law Disclaimer: These are the rules and requirements of VVDCS Private School Satellite Program as the law allows. If at any time you wish to transfer to another school, especially, a public campus school, your student will have to comply with the health & immunization requirements there.

VVDCS HEALTH AND SAFETY POLICY (REVISED. 05/01/2023)

<u>Introduction</u> Victor Valley Desert Christian School (VVDCS) shall strive to protect the safety and health of students in our school/support group as well as their families, and our staff. This health and safety policy has been developed from the guidelines recommended by the Center for Disease Control, the National Association of State Boards of Education, the California Department of Health, and the California State Board of Education.

<u>Privacy</u> Pupils and staff members are not required to disclose personal health information to anyone. If information or speculation about an individual student's or staff member's health is shared with the administrators for the purpose of assessing potential special needs or enforcing school a policy, such information is treated as highly confidential. Access to student health records and related information is available only to the administrators and to the student or, if the student is a minor, to his parent or guardian, except as required by law (HIPPA, etc).

<u>Education</u> With the goals of healthful living and avoiding risks of injury, illness, and disease, VVDCS will make this health and safety policy available on an annual basis and will require, as a condition of enrollment, that every parent sign a notice of receipt and agreement to follow these policies at all school activities.

<u>Enrollment Non-Discrimination</u> No student will be denied enrollment in VVDCS based solely upon the presence of an injury, disability, illness, or disease. However, under certain conditions (explained below under "exposure control") a student may be excluded from participation in group activities.

<u>School Entry Health Exam</u> Parents of incoming first graders are required by law to submit a school entry health exam report from their physician, or to sign a waiver of the exam. This report is kept on file with the student's permanent record.

Immunizations VVDCS complies to record that, in accordance with state law, every student be fully immunized for the following diseases, unless a waiver based upon personal beliefs been signed by the student's parent or guardian, or a waiver based upon medical reasons has been signed by the student's physician: 1) diphtheria; 2) haemophilus influenzae type b, except for children who have reached the age of four years and six months; 3) measles; 4) mumps, except for children who have reached the age of seven years; 5) pertussis (whooping cough), except for children who have reached the age of seven years; 6) poliomyelitis; 7) rubella; 8) tetanus; 9) hepatitis B, for all children [entering school] on or after August 1, 1997; 10) varicella (chickenpox), effective July 1, 2001, except for students already enrolled in kindergarten or above before July 1, 2001. Parents of all students must present a written immunization record or signed waiver to be kept on file by the school within 10 days of enrollment. As a non-campus private school, vaccinations are not required by law for enrollment in VVDCS.

Health and Safety Policy Cont. page 2

<u>Exposure Control</u> Because of the family nature of the program offered by VVDCS, policies and procedures adopted in institutionalized school settings may not offer the level of safety necessary to reasonably prevent health hazards. While no one can guarantee that no injury will ever occur nor illness or disease be contracted, the following policies are adopted for the health and safety of all students and their families.

- 1. <u>Injury Prevention and Response</u> We recommend the following guidelines, adapted from the Center for Disease Control guidelines and for our unique educational setting that: A) all parents and students in grade nine and above take the Basic First Aid and CPR course offered by the Red Cross. B) if an injury to a child occurs, the parent of the injured child should be the person to give first aid or other treatments. C) Universal Precautions be followed when blood or bodily fluids are present, including the use of latex gloves by those treating the injured or ill person and by those cleaning up. D) all parents have and maintain their own simple first aid kit, including latex gloves, bandages, Band-Aids, and antibacterial cleaning solution. Such a kit can be kept easily in a purse or car to have available in an emergency.
- 2. <u>Presence of a Contagious Illness or Disease</u> Students and family members may not participate in group activities sponsored by VVDCS unless they are free from contagious illness. If you are ill, please stay home to avoid exposing others. If an attendee at an event manifests symptoms of any potentially contagious disorder (i.e. fever, severe coughing or sneezing, evidence of lice infestation, oozing open wounds, sores or rashes, etc.) or any other condition which reasonably causes health concerns among staff or parents present, that person will be asked to leave and may be excluded from attending VVDCS functions until he has demonstrated that the condition has abated or the contagious period has ended.
- 3. <u>Notification of Exposure to Communicable Disease</u> Whenever the administrators have good cause to believe that a student may have been exposed to a disease, that information shall be reported by the administrators to the student's parent. In conjunction with the recommendation of the local health officer related to the pupil's risk of developing the disease, the administrators may require the exclusion of the student from school activities until the completion of the incubation period and the period of communicability of the disease.
- 3A. <u>COVID-19 Pandemic Addendum</u> VVDCS is doing everything we can to reduce the risks of exposure to you and to organization and its partners. To this extent, we will consider the Center for Disease Control (CDC) and local health department guidelines with regard to practices in order to reduce the spread of Novel Coronavirus, or COVID-19. This will require our staff and visitors to attempt social distancing between ourselves as much as possible. We will NOT require all individuals to utilize a face covering. Everyone must agree to reduce the spread of germs by agreeing to wash or sanitize their hands after using the restroom, sneezing, coughing, and before eating or preparing meals or supplies for distribution and use disposable gloves where necessary. VVDCS will also implement higher cleaning standards of our restrooms and working areas before and after meetings and as much as possible. If you're sick, or think you or your children have been exposed, stay home until you're sure that you're not contagious. Thank you.

- 4. <u>Ongoing Medical Conditions</u> If a student or family member has continuing special medical needs, VVDCS will make a reasonable effort to accommodate those needs. However, all accommodations will be considered by balancing the special need of the individual with the general needs of the group. If you are unsure whether a particular activity can accommodate specialized equipment or other needs, please ask before attending.
- 5. <u>Administration of Medicine or Procedures</u> No one other than the parent or guardian of a student may administer medication or other medical procedures to that student (i.e. asthma inhalants, insulin shots, aspirin, etc.)
- 6. <u>Parental Supervision</u> We require that a parent or guardian attend all events at which their child is present. In the case of an illness or condition which presents any special considerations in the event of a health emergency (i.e., diabetes, epilepsy, HIV, etc.) we require that the parent or guardian remain in close enough proximity to the student that should there be a medical emergency, the parent can reasonably be the first to respond and administer proper procedures for both the safety of the affected student and others.
- 7. <u>Anti-Molestation and Abuse Clause</u> We require that any person, adult, child, or volunteer disclose to the school any information about alleged or convicted abuse cases they may have been involved in. This includes anyone listed as a registered sex offender. Because of this concern, no adult should be left alone with a child without the parent's advance permission.
- 8. Exclusion from Activities No student or family member will be permanently excluded from activities hosted by VVDCS based solely on the existence of a medical condition. If the particular condition creates a risk to others or is a need which we cannot accommodate without unreasonably sacrificing the benefits of the activity or the needs of others, the administrators will meet with the parent to attempt to resolve the issue consulting with local health officials or obtaining other medical advice if necessary to assist in determining appropriate action. In such cases, the decision of the administrators will be final.

Conciliation The parties to this agreement are Christians and believe that the Bible commands them to make every effort to live at peace and to resolve disputes with each other in private or within the Christian church (see Matthew 18:15-20; 1 Corinthians 6:1-8). Therefore, the parties agree that any claim or dispute arising from or related to this agreement shall be settled by biblically-based mediation and, if necessary, legally binding arbitration in accordance with the Rules of Procedure for Christian Conciliation of the Institute for Christian Conciliation, a division of Peacemaker® Ministries (complete text of the Rules is available at www.HisPeace.org). Judgment upon an arbitration decision may be entered in any court otherwise having jurisdiction. The parties understand that these methods shall be the sole remedy for any controversy or claim arising out of this agreement and expressly waive their right to file a lawsuit in any civil court against one another for such disputes, except to enforce an arbitration decision.

The following Code of Conduct is applicable at all VVDCS functions including, but not limited to, park days, field trips, meetings, parties, promotional/graduation ceremonies, group classes, etc.

This policy also applies to all guests at any VVDCS function.

- Physical Education − physical activities conducive to health and vigor of body and mind, for at least 200 minutes each 10 school days − 20 minutes a day.

- 1. For grades 7-12 you are required to turn in one report card for each semester (twice a year. See school schedule for the due dates.)
- 2. You may fill in "quarter" or "semester" grades as applicable and "FINAL" grade is needed for "two semester" courses
- 3. Use the grade scale on the report card to receive honors credits on your diploma.
- 4. Title each academic subject appropriately. For example: Under the heading of *Physical Education* you may add "baseball, soccer, swimming, etc.," under *Bible* you may add "NT Survey, Life of Jesus, etc.,"
- 5. Keep the original form in *your* records and turn the other into the school.
- 6. Please refer to your copy of <u>The High School Handbook</u> for specifics on each of the corresponding subjects.
- L **Bible**—a developed curriculum is recommended or you may design your own course of study if you choose.

Graduation requirements: Jr. High = 20 credits, Sr. High = 40 credits

Legish—including a knowledge of and appreciation for literature (see The High School Handbook for recommended reading), language, and composition and the skills of reading, listening and speaking.

Graduation requirements: Jr. High = 20 credits, Sr. High = 40 credits.

- Mathematics—including instruction designed to develop mathematical understanding, operational skills and insight into problem-solving procedures.
 Graduation requirements: Jr. High = 20 credits, Sr. High = 20-30 credits.
- ► Physical Education—with emphasis given to physical activities that are conducive
 to health and vigor of body and mind.

Graduation requirements: Jr. High = 10 credits, Sr. High = 20 credits.

- Science—including the physical and biological aspects, with the emphasis on basic concepts, theories, and processes of scientific investigation and on man's place in ecological systems, and with appropriate applications of the interrelation and interdependence of the sciences. One of the science courses must include laboratory work where experiments & hands on activities are stressed.

 Graduation requirements: Jr. High = 10 credits, Sr. High = 20 credits.
- L **Social Sciences**—drawing upon the disciplines of anthropology, economics, geography, history, political science, psychology, and sociology, designed to fit the maturity of the student. <u>The following topics are required: World History & Geography, United States History, American Government & Civics & Economics.</u>
 Graduation requirements: Jr. High = 10 credits, Sr. High = 32-35 credits.

ELECTIVES—The following electives ARE REQUIRED for graduation.

- Applied Arts [running a household]—including instruction in the areas of consumer (how to use a checking account, comparison shopping—auto, food, etc.) and homemaking (sewing, cooking, cleaning, etc.), education, industrial arts (welding, plumbing, carpentry, etc.), general business education (economics, starting & running a business, etc.) or general agriculture (gardening, live-stock raising, etc.) Graduation requirements: Jr. High = optional, Sr. High = 2 ½ 5 credits.
- Automobile Driver Education and Drivers Training [optional]—designed to develop a knowledge of the provision of the Vehicle Code and other laws of this state relating to the operation of motor vehicles, a proper acceptance of personal responsibility in traffic, a true appreciation for the causes, seriousness and consequences of traffic accident, and to develop the knowledge of and attitudes necessary for the safe operation of motor vehicles. A course in automobile driver education shall include education in the safe operation of motorcycles. (Usually taught in conjunction with Health.) Graduation requirements: Jr. High= none. Sr. High= none.
- └ **Fine Arts**—including art, music, or drama with emphasis upon development of

aesthetic appreciation and the skills of creative expression.

(Can substitute for an additional 10 credits of foreign language. Must be of the same language taught). Graduation requirements: Jr. High = optional, Sr. High = 10 credits

- ☐ **Foreign Language-** One year of language study or two years of same language study for college prep requirements. Graduation requirements: Jr. High = optional, Sr. High = 10 credits.
- Health—principles and practices of individual, family, and community health, including effects of alcohol, narcotics, drugs, and tobacco. This topic may be taught as a semester of science or in conjunction with Automobile Driver Education.
 Graduation requirements: Jr. High = optional, Sr. High = 2 ½ 5 credits.
- Parenting Skills—designed to develop a knowledge of topics including, but not limited to: child growth and development, parental responsibilities, household budgeting, child abuse and neglect issues, personal hygiene, maintaining healthy relationships, teen parenting issues, and self-esteem. Should be taken at the Junior High Level, but is a requirement for Senior High graduation. Graduation requirements: Jr/Sr. High = 5 credits.
- Vocational/Technical Education [work study or job training]—designed and conducted for the purpose of preparing youth for gainful employment in the occupations and in the numbers that are appropriate to the manpower needs of the state and community served and relevant to the career desires and needs of the students. (i.e. auto shop, landscape maintenance, computer programming, catering, childcare, etc.) Graduation requirements: Jr. High = optional, Sr. High = 2 ½ 5 credits.
- Typing/Computer Skills—to gain basic keyboarding ability and proficiency in office computer software. Graduation requirements: Jr. High = optional, Sr. High = 2 ¹/₂ -5 credits.

Additional Requirements for Grades 7-12

- L The minimum number of credits for a student to graduate from VVDCS Senior High School is 225.
- ☐ Graduating senior high students must show proficiency or take a standardized exam to be determined on a case- by-case basis.
- □ Parents with students beginning their 11th grade year must meet with the school administrator to review credits and project their graduation goals will be met.
- △ A student must, at least, attend their last two years of high school at VVDCS in order to graduate from our Senior High School.

Concurrent Enrollment for College Credits

If you believe your student has the maturity and academic ability to complete college level coursework during their high school years, and that this would be in the best interest of the student, they may be able to enroll in a college program to complete both required high school courses and college courses simultaneously.
